# **NEWP Interim Steering Group**



#### Role

The Environment and Invasives Committee (EIC) has given in-principle endorsement of the National Established Weed Priorities (NEWP) Framework, following extensive public consultation over the last 18 months. Further broad support for the Framework was also obtained at a national peak body round table on 31 August 2022. Final approval of the NEWP Framework by EIC is pending the development of an approved implementation plan.

An interim steering group is being convened to provide strategic advice to Wild Matters Pty Ltd in drafting elements of the Framework's implementation plan. The existing EIC Weeds Working Group NEWP Taskgroup will be expanded to include additional non-government members from stakeholder sectors, to form the **NEWP Interim Steering Group** (ISG).

The NEWP ISG is an advisory body and will peer review the following components of the implementation plan:

- WoNS/WINS nomination and assessment plan
- WoNS/WINS strategic plan guidance
- investment strategy
- national coordination and governance plan
- communication plan
- draft NEWAL strategy
- NEWP Steering Group terms of reference

Wild Matters will provide drafts of these components as agenda items for NEWP ISG meetings. It is envisaged there will be up to four, two hour online meetings held during October-December 2022, with reading required beforehand. Draft documents will be provided a week prior to a meeting. Please note these are not for public distribution.

NEWP ISG's review and discussion of these documents will include advice on their logic, feasibility, stakeholder appeal, preferences (where options are given), completeness and risks. NEWP ISG will also advise on any further stakeholder consultation required.

#### **Nomination Process for new members**

General expressions of interest (EoIs) are being sought. These may come from either individuals or organisations (nominating a person of their choice with respect to the member requirements).

#### **Member requirements**

Members of the NEWP ISG will be selected based on their skills, knowledge and/or experience in the following areas:

- program governance and implementation
- strategic weed management at the landscape level
- current/past involvement in one or more of the following sectors
  - government (Australian, State/Territory and Local)
  - community (First Nations, biodiversity conservation, natural resources management, community volunteer groups)
  - o industry (agriculture, forestry, other industry)
  - o science
- determining cross-sectoral priorities (at a national or state/territory level)

Participation in ISG meetings should be by the nominating member. For consistency, proxies will not be accepted.

All persons on the NEWP ISG will act in a respectful and constructive manner, acknowledging that others may have different viewpoints on particular matters.

## **Conflicts of interest**

Members are not appointed as representatives of particular organisations and are expected to take a wider, national, sectoral and cross-sectoral view. Members are not to use information gained at meetings for the advantage of their organisation.

Any conflicts of interest will be declared at the commencement of a meeting.

### **Term**

The NEWP ISG is time bound and ends when all sought strategic advice has been provided on relevant components of the draft NEWP Framework implementation plan.

The NEWP ISG is separate to the envisaged NEWP Steering Group, which will be formed when the Framework commences implementation. There is no automatic shift of members from the former to the latter.
